2021 Love Boat Race Sunday, February 14th, 2021

1. ORGANIZING AUTHORITY

Rush Creek Yacht Club, Heath, Texas ("RCYC"), as the organizing authority, presents the 2021 Love Boat Race.

2. RULES

- 2.1. The regatta is governed by The Racing Rules of Sailing 2021-2024 with the prescriptions of United States Sailing Association ("RRS"), this Notice of Race, and the Sailing Instructions.
- 2.2. The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions that will be on the official notice board located at RCYC on the window immediately South of the southernmost back door.
- 2.3. The RCYC Go/No Go Chart will be used at the discretion of the Race Committee.
- 2.4. All sailors will follow RCYC, local, state and federal social distancing and COVID-19 guidelines.

3. ELIGIBILITY and ENTRY

- 3.1. This regatta is open to all sailboats for which a member of RCYC is the Person in Charge.
- 3.2. Fleets will be determined on Race Day, with expected PHRF Spinnaker, PHRF Cruiser and Portsmouth.
- 3.3. All boats may enter by registering in person at the club. ALL ENTRIES must check-in before the Skipper's Meeting at 12:55 PM, Sunday, February 14th, 2021.

4. **FEES** Entry Fee for the regatta is \$0.00 Feel Free to donate any entry fee to RCYC Youth Foundation

6. THE COURSE

- 6.1. The course will be announced February 14, 2021.
- 6.2. The course will be announced during the Skipper's Meeting and in the Supplementary Sailing Instructions. Expect a 1.5-hour race using RCYC's permanent marks.

7. SCORING

- 7.1. Pursuit Start based on a boat's Lake Ray Hubbard PHRF rating will be used.
- 7.2. All classes will be scored based on PHRF Time-on-Distance scoring.

8. RISKS AND DISCLAIMER OF LIABILITY

- 8.1. It is critical to be mindful of how you feel, and particularly when ANY of the potential COVID-19 symptoms are present to stay home.
- 8.2. Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race.
- 8.3. The race organizers (organizing authority, race committee, protest committee, Rush Creek Yacht Club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
