<input type="checkbox"/> Junior	Those members at least 12 years of age but less than 21 years of age. Non-voting and non-transferable. <i>Initiation Fee: \$75, Monthly Membership Fee: \$30.</i>
<input type="checkbox"/> Student	For individuals enrolled as full-time students in an accredited school and are at least 21 years of age but less than 25 years of age. Non-voting and non-transferrable. <i>Initiation Fee: \$75, Monthly Membership Fee: \$30.</i>
<input type="checkbox"/> Crew	For individuals participating in racing activities. Membership is renewed on an annual basis. No boats or launching privileges. Non-voting and non-transferrable. Crew Certification Form required in addition to this Membership Application. <i>Initiation Fee: \$50, Monthly Membership Fee: \$40, Monthly Bar and Grill Minimum: \$40.</i>
<input type="checkbox"/> Social	For individuals who do not sail but support racing activities of the Club. A social member can use the club facilities but cannot have a boat on the property and has no boat launching privileges. This type of membership is for a new member or a person who was a crew member. Non-voting and non-transferable. <i>Initiation Fee: \$450, Monthly Membership Fee: \$80, Monthly Bar and Grill Minimum: \$40.</i>
<input type="checkbox"/> Non-Resident	Available only to persons who are fully-paid members and live more than 100 miles from RCYC. On returning to the 100 mile radius, the member is no longer eligible for this status. <i>Yearly Fee of \$170.</i>
